## PRODUCT USE / APPLICATION:

**ROCK-POWER** can be safely applied using mechanical floor scrubbers, pressure washer, used in 'dip' tanks, mops, spray bottles or rags.

Surfaces that are heavily soiled should be treated with full strength **ROCK-POWER** and allowed to soak for several minutes before agitating and rinsing. Stubborn stains / grease may require more than one application of **ROCK-POWER** to completely remove.

## CLEAN UP:

Be sure that all application tools and equipment (including cleaning buckets, mops, scrubbers, etc.) are thoroughly rinsed and cleaned using fresh water.

## DISPOSAL:
